Upcoming Deadlines and Reminders

January 23rd, 2024 is the deadline for the 2023 Pay for Performance (P4P) incentive program and 2023 case volumes.

Here are a few tips to help you as you work towards this deadline:


Clinical & Physics:

- Missing forms for Breast, Lung, and Mets should be <5% for 2023 patients with an RT end date between 10/1/22-9/30/30
- Data checker errors need to be cleared for all databases (*Metrics C and D*)

Last Chance to earn Bonus Points!

Don't miss an opportunity to receive bonus points via the Bone Mets Knowledge Transfer Project.

MROQC Bone Mets Knowledge Transfer Project Aim:

To increase awareness and gather honest feedback about using single fractionation on

eligible patients. To assess the success of the project, we will compare the usage of single fractionation treatment on uncomplicated patients prior to and after the project initiation.

Goal: All MROQC sites complete the Knowledge Transfer Project

What does an MROQC site need to do?:

Successful completion of the following steps by a least ONE physician (doesn't have to be the Clinical Champion!) per site will result in 5 bonus points towards a site's final 2023 incentive program performance scoring (which may help compensate for any lost points due to not meeting the bone mets measure)

Steps to Successful Completion:

- 1. Watch the brief video by Dr. Candice Johnstone **Mythbusting: 8Gy x 1** (located on the MROQC YouTube channel)
- 2. Complete the MROQC Bone Mets Knowledge Transfer Post-Session Survey
- Attend a Q & A session by December 19, 2023 (select the date that works for you in the survey and an invitation will be forwarded to you or reach out to support@mroqc.org)
 - November 21st 12:30-1:00 pm
 - December 19th 12:30-1:00 pm

4.Success!!! 5 points (total) will be awarded after 1 physician attends a Q & A session.

(if you completed steps 1 & 2 but have not attended a Q & A session, you will not receive 5 points)

Prostate:

Forms updates have been made to SE1, P3 & P5

- Treatment dates have been added to the SE1 Enrollment form.
- Genomic test scores are now captured on the P3 Physician Androgen Deprivation Therapy form.
- Sites can now indicate why a P5 Prostate Patient Follow-up form was not completed.

Bone Mets: The M2 CDA Bone Mets Baseline Medication Reconciliation form has been discontinued.
